Minutes Supervisors' Meeting July 10, 2025

The Board of Supervisors of Washington Township, Westmoreland County, met in Regular Session at 7:00 p.m., at the Municipal Building on July 10, 2025. Present were Supervisors Gardner, Olszewski and Thornton, as well as Solicitor Long of Long & Long and T.J. Stephens of Bankson Engineering Inc. The meeting was called to order by Chairman Gardner and opened with the Pledge of Allegiance.

Hearing no request for discussion on any items on the agenda, Gardner announced the following: 412 Rally will hold a car show in Kunkle Park on Friday, July 18th from 2 pm to 8 pm and the Northmoreland National Night Out will be held on Wednesday, August 6th, from 5 p.m. to 8 p.m. at Northmoreland Park, Pavilion 8. This free event is open to the public. Come and meet your local police and first responders.

TOWNSHIP ENGINEER'S REPORT

Board of Supervisors Meeting: August 14, 2025

CURRENT ENGINEERING ITEMS:

- 1. Municipal Separate Storm Sewer System (MS4) National Pollution Discharge Elimination System (NPDES) Individual Permit:
 - a. BEI submitted the Renewal Application to PA DEP on 3/12/2024. **PA DEP issued the Permit on 7/29/2025.**
 - b. MS4 Pollution Reduction Plan (PRP) Amendment for the Beaver Run Watershed:
 - i. Proposed MS4 PRP BMP projects:
 - 1. Improve existing stormwater pond at the maintenance garage.
 - 2. Streambank Restoration Project (Leonard Property)
 - a. BEI prepared an easement document for the streambank project and shared with the Township for execution.
 - ii. BEI is finalizing the Pollution Reduction Plan Amendment
 - 1. Next Steps:
 - a. BEI will provide a copy of the document to the Supervisors for review and input.
 - b. A 30-day public comment period will be needed.
 - c. Submission to PA DEP for approval.
- 2. Pickleball Courts at Kunkle Park
 - a. BEI was requested to assist with the design of pickleball courts at Kunkle Park.
 - b. Final Design Drawings were delivered to the Township at the April 2024 meeting.
 - c. After discussion with the Supervisors on 6/30/2025, BEI made minor design revisions (drainage and court dimensions).
 - i. A revised drawing set will be provided to the Township at the August Meeting.
 - d. BEI understands that the Township will pursue COSTARS vendors to furnish and install the courts, as designed. Bidding documents will not be prepared by BEI at this time.
- 3. Myers Well Service Low Volume Driveway Stormwater Management Plan
 - a. Stormwater Management Plan was submitted by Gibson-Thomas on behalf of Myers Well Service on July 10, 2025.
 - b. BEI reviewed the Stormwater Management Plan and issued a letter recommending approval. Our letter included four administrative comments which should be addressed by Myers Well Service as conditions of their approval.
